What if I don't qualify for help?

CLS is not always able to help, even if you are eligible, since its staff and volunteer attorneys and other resources are limited.

People are often found ineligible because:

- Case type (traffic disputes, criminal cases)
- Income requirements set by federal standards
- · Lack of staff resources

In the Denver Metro Area, some cases are referred to Metro Volunteer Lawyers (MVL), that provides free legal services to those who qualify. Volunteer attorneys are also available in many other parts of Colorado.

How will CLS help me?

CLS provides free legal advice and representation to eligible low-income persons, and persons 60 years of age and older (in most counties), in civil legal matters.

CLS' focus is to enforce and defend clients' legal rights to meet their basic human needs, including shelter, safety, food, health, and income.

CLS may provide legal advice, brief services or full representation, depending on client needs and CLS' resources. In certain instances, cases may be referred to clinics or other agencies for additional help. Services are provided in a client's primary language.

Have the following with you when you apply:

- Information about income and assets including employment, benefit statements, amount of cash on hand and in bank accounts.
- Names and ages of all household members.
- Court papers or documents that are part of your current legal issue.

You may qualify for free civil legal aid if you meet income and asset requirements, or if you are a senior 60 years of age or older and live in certain/most Colorado counties.

CLS does **not** provide help in criminal cases (except for criminal record sealing), in traffic disputes, or in fee-generating cases such as auto accidents, personal injury, and workers' compensation.


