Funding: The recreation center is being funded by marijuana tax revenue. Time Frame: The public input process now though summer 2019. Design, review, contractor selection, and permitting process: Fall 2019 through summer 2020. Construction: Summer 2020 through summer 2022. Projected opening in early 2023.
