## **MINUTES**

## VI. NEW BUSINESS

a) Naomi Amaha Gollnick, Community Advocacy Director with the American Heart Association, works with local community leaders on policy issues. She presented information on marketing tactics used by big corporations to expand sales of high-sugar beverages and she talked about the negative health impacts of consuming sugary beverages, particularly for young people. AHA and others are looking at how restaurants in Aurora advertise their meal bundle menus to youth and families, and trying to get businesses to advertise non-sugary beverages, e.g. milk and water, in their youth-oriented meal packages. They are looking at a possible city policy to regulate this advertising practice in restaurants. Naomi will keep AYC informed about this effort.

## VII. OLD BUSINESS

- a) AYC Sub-Committee updates:
  - a. Josue shared the process to-date of the AYC By-Laws revisions. AYC members reviewed the proposed changes to the by-laws through a second reading. Josue moved to adopt the proposed changes to the By-Laws, 2<sup>nd</sup> by Caleb Weiss. A roll call vote was taken. The motion passed unanimously, and the AYC By-Laws are officially adopted.
  - Communications sub-committee is creating a list of questions to interview youth in Aurora to produce a video for City Council. More details will be sent after the meeting.
