At the Commission meeting on October 20, 2015, the Civil Service Commission unanimously voted to extend the 2015 Police Captain Certification list by 90 days. The Commission cited budgetary concerns as the primary reason for this Charter-authorized extension. Therefore, the 2015 Police Captain Certification list will now expire August 15, 2016 or upon certification of a new list.

The Police Captain Assessment Center is tentatively scheduled to be held August 3-4, 2016. A promotional notice will be published in May 2016 formally announcing these dates.




