At the regularly scheduled meeting on October 20, 2015 the Civil Service Commission unanimously voted to extend the 2015 Fire Lieutenant Certification list by 90 days. The Commission cited budgetary concerns as the primary reason for this Charter-authorized extension. Therefore, the 2015 Fire Lieutenant Certification list will now expire June 25, 2016.

The Fire Lieutenant written exam will be tentatively scheduled for Wednesday, May 11, 2016. The Fire Lieutenant Assessment center will be tentatively moved to June 8-9, 2016. A promotional notice will be published in February, 2016 formally announcing these dates and reading list for the written exam.
