At the regularly scheduled meeting on November 7, 2017 the Civil Service Commission unanimously voted to extend the 2017 Fire Lieutenant Certification list by 90 days. The Commission cited budgetary concerns as the primary reason for this Charter-authorized extension. Therefore, the 2017 Fire Lieutenant Certification list will now expire September 7, 2018.

The Fire Lieutenant written exam will be tentatively scheduled for July 18.2018 and the assessment center will be tentatively scheduled August 21-23, 2018. A promotional notice will be published approximately 90 days in advance formally announcing the exact dates and reading list for the written exam.
