### **CALL TO ORDER**

No call to order. No quorum.

#### **Mayor Mike Coffman**

Mayor Coffman talked w/Governor and he believes by next month we will have enough vaccines so that we will no longer need the prioritized categories.

The Mayor knows there was frustration with the 5-star program. The governor delayed movement stating he wanted 70% of the seniors vaccinated before that could occur.

Today we are dealing with a major snowstorm. Tune into social media for links about the plan for the city priorities for snow removal from major arterials to side streets and so on.

With the passage of the Federal Stimulus bill, the city of Aurora will be receiving money and small business will be a priority to receive some of those funds.

#### IFC - Commander Wright

City Council has asked to reconvene with AFD regarding the inspection fees. They have questions regarding the fees that are being proposed. And they are doing that tonight. So, Commander Wright will hold off on anything further until after they meet with City Council.

Mr. Walls asked what the process is with the fee structure. Does the AFD have complete authority over that or does City Council need to sign off?

Commander Wright replied that the City Council will approve AFD to have the authority and then the actual schedule and price points and fees are all up to AFD. The AFD presented 3 fees to council last fall.

1) Inspection fee, 2) scene mitigation fee and 3) patient refusal fee. The City council would like to revue the last 2 fees.

Mr. Walls asked what the patient refusal fee is?

Commander Wright responded the patient refusal fee is for non-citizens of Aurora who call 911 unnecessarily. Abuse of 911 for non-Aurora citizens.

### Trevor Vaughn, Manager of Tax and Licensing

**Updates**:

The third-party delivery fee cap, which was set to expire at the end of the March was brought back to city council to extend to June 30 or earlier when restaurants reach 100% capacity.

The lodgers tax modification exemption is a going through the final stages of council.

The menstrual care products exemption is proceeding through city council and appears it is going to pass. It did receive a little bit of media attention.

The default sugary sweetened beverage item has been postponed. Councilmember Lawson wants to give an opportunity for people to come in person and voice their opinions on that.

The Five Star Program in blue, particularly those that have large space will get to have an extra 50 people in their 50% capacity. And then that second level, set to 25 it's 275 capacity. They don't get to operate in green. Third Party facilitator has really done quite well. Turns out there's a lot more revenue from than we anticipated forcing companies like Amazon and eBay to collect sales tax from sales that they're facilitating on their websites.

### Molly Steinemann CRA -

Throughout 2020, Colorado restaurants collectively lost more than \$3 billion due to closures.

The Colorado Department of Labor and Employment reports that in December 2020 and January 2021, leisure and hospitality employers shed 41,600 jobs while all other sectors combined have added 16,600 jobs. Roughly 40% of the industry's employees have been laid off or furloughed due to COVID-19. That's two out of five people.

Based on current staffing levels, we estimate that the industry has shed roughly 94,000 jobs in the past year. If nothing changes, approximately 50% of restaurants are telling us that they will have to consider permanently closing within less than six months.

A restaurant unfortunately can't even begin to recover until they're back to 100% indoor capacity.

This is an industry that operates on 3 to 5% profit margins. If these businesses are being asked to operate at 50%, they simply cannot make the numbers work.

The first most restaurant specific piece of legislature is the extension of the state sales tax holiday that applies to restaurants in November 2020 through February 2021. It has been extended through the summer months.

This industry needs to get vaccinated as quickly as possible.

We're asking for alcohol "to go" to be a permanent allowance or at least continue down to the future, So the restaurant tourism can continue to use that as a tool for recovery.

We're asking that Colorado reclassify Cares Act grant funding for restaurants as nontaxable income.

We're asking about federal stimulus funds to be used to backfill the state unemployment Trust Fund.

Mr. Walls asked Ms. Steinemann what does the overall recovery look like for Aurora restaurants?

Ms. Steinemann replied I'm hearing from them that the way the state dial is currently formulated, they really aren't going to be significant capacity increases as we move to level blue and green, because of the six feet of social distancing required between tables. If you're a restaurant with a smaller footprint, six feet between tables might actually keep you at 15 to 25%.

they don't see a clear path to increase capacity under the current dial restrictions.

Mr. Walls asked Ms. Steinemann what are some key points we can take to city council and advocate for?

Ms. Steinemann replied as this industry is vaccinated, that's going to be a pretty significant boost in the health and safety of restaurants. So as we see more and more industry employee vaccinations, it's our opinion that we should then see some increased capacity limits tied to that rate of vaccination.

Anything restaurant specific as far as grants and loans at the city level you can advocate for would be incredibly helpful for your local restaurants.

Mr. Walls asked Ms. Steinemann if she had the number of closures for the Aurora Restaurants?

Ms. Steinemann - Unfortunately, we can't find good data because the state reports don't distinguish between temporary and permanent closures. So, turn it over to Trevor.

Mr. Vaughn - I would say, Aurora has fared better than downtown Denver. The financial strain on these businesses, takes a while for it to take its toll. So, when you start to see businesses struggle financially, it can take them a while before they give up. So, I would expect that we'd see continued closures for the foreseeable future.

A new COVID dial is expected at the end of March. They haven't put a metric into the dial as to when this ends. It'd be good to see a metric as to what's the end point here.

#### **Council Member Coombs**

Council member Coombs has a terrible internet connection and will not be able to join us today.

#### Rachel Gruber, Manager of Community Affairs at DEN

Seneca Holmes, Director of The DEN Commerce Hub and Desiree Mondragon, DEN Events and Marketing Coordinator for the Hub.

Den's domestic network has remained robust, even during the pandemic.

Den has concentrated projects meant to improve the passenger experience and accommodate commitments to airline carriers. Den moved forward with two of the largest projects: the Great Hall project and the gate expansion projects. Den also accelerated work to renovate the concourse and upgrade restrooms or hold rooms, seating, wayfinding, gate ramp areas, and took advantage of lower passenger traffic.

Also doing a lot with Pena Boulevard. Reconstructing new lanes on Pena Boulevard inbound, relocating return to terminal loop to Jackson gap Street, bridge maintenance and repairs, operation and safety improvements and some work on the pavement which has reached its life expectancy.

Community Panelist program – DEN is looking for folks who are looking to enter the airport marketplace, participating as a community panelist member. It is a good educational tool, so that people get an understanding of what it takes to work at DEN. There are lots of procurements that need evaluation, and so DEN is recruiting as many folks as possible in all areas.

Mr. Walls – Regarding business operations, how have things gone in the past year, occupancy and vacancy rates?

S. Holmes – Den released the MAG – minimum annual guarantee that's owed to the airport. Concessionaires have either shut down or have flexible hours. 128 concessions are now open. It is expensive to open a concession. People have been able to hold on. But unless we have some rapid growth, it may not be possible to hold on in the future.

Mr. Walls has seen this presentation 6 months ago and DEN was number 1.

S. Holmes – it fluctuates from day to day depending on the week.

#### **Business Awards Update** – Elena Vasconez

Last week Channel 8 started visiting all the businesses and recording the videos.

Confirmed keynote speaker; Patrick Hollowell. He is the economist for Arapahoe County. 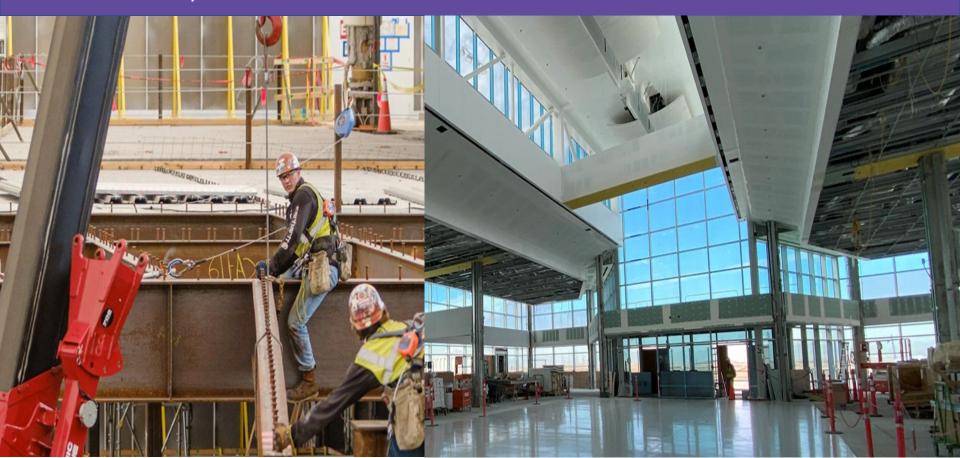

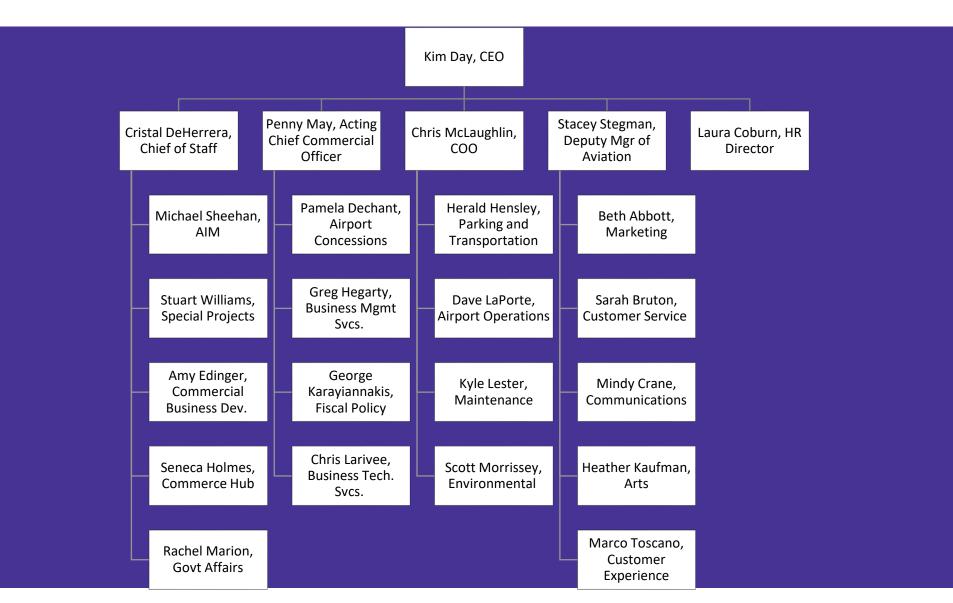

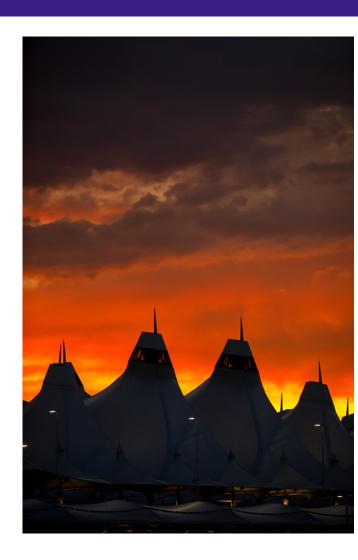
