Abstract: This collection consists of records from 1916 to 194 for Arapahoe County School District 62. In the early years this consisted of one school building and one teachers covering through grade 7. Census records for enrolled students, some attendance records, Teacher and Principal Annual Reports, Secretary Report, Arapaho tax levies, Budgets, Annual Financial Statements, and Quarterly and Yearly reports of Treasurer to the School District.

Arapahoe School District 62 was organized in 1889. Its name was listed as 'Day, Altura'. The unincorporated community of Altura was located roughly between present day Chambers and Laredo streets straddling the Adams – Arapahoe county line. It is now part of the Adams - Arapahoe consolidated joint School District 28J. Today there is an Altura elementary school in that area. The documents are for the Day School. In the Record of District Meetings, Altura, August 5, 1916, Organization of School District 62, includes notes on the election of James L Day as the President. In another document he is listed as a school district Director. This suggests the Day School was named for him and is not associated with a community or location named Day.

Arrangement: The folders are placed in date order with the oldest start date first. The material in the folders is organized with the oldest date first.

Folder 1: 1916-1919. District Record for the Use of District Secretary, Altura. This includes meeting notes of the school district meetings, Treasurer's account of payments, and register of school district directors.

Folder 2: 1917-1941. District 62 Census Lists. These includes student name, place date of birth, last school grade, and father and mother with nationality.

Folder 3: 1920-1941. Quarterly and Yearly Statements to Treasure to School District 62.

Folder 4: 1934-1940. Annual Report 1927; Budget 1934-40 & 37-38 s.y.; Annual Financial Report 37-38 s.y. and 39/40; Abstract of Assessment and Levies Arapahoe County 1938, Tax Levies 1940.

Folder 5: 1927-1941. Day School Teacher's or Principal's Annual Report. This includes enrollment broken down by grade, gender, buildings, studies pursued, textbook used, etc. Note - for 1926-1927 school year, there were 8-10 students and one teacher.

Folder 6: 1937-38 & 1940-42. Colorado Teachers Registry, 1. Netra Taylor s.y. 37-38, 1-7. Provides grades, attendance, date of birth, parent/guardian, address (note - lists 'Aurora' as residence); 2. Mary Kellogg s.y. 39-40 & 40-41. Note - includes Adams County students. Lists parent/guardian addresses with some in Denver and one in New York.

Folder 7: 1938-1941. Secretary's Annual Report to the County Superintendent of Schools. This includes mill levies, district property value, general fund, disbursements, cost per pupil, etc.

Folder 8: 1939-1941. School Laws Enacted 1939; Secretary's Bulletin s.y. 1940-41; Arapahoe County Schools April 1941: Junior High Track Meet rules, Annual meeting of Teacher's Association, Music Festival, Arapahoe County C.Y.C.L. chapter assembly.

Folder 9: 1939-1941. Annual teacher's contracts for Mary Kellogg.
