# Sec. 2-851. Created; composition.

There is created and established a veterans' affairs commission, consisting of 11 voting members and one nonvoting member. The 11 voting members and the alternate member shall be registered electors and shall be either on active duty in a uniformed service of the United States or serving as a traditional Guardsman/Reservist or Individual Mobilization Augmentee or they shall be honorably discharged from a uniformed service of the United States. Members shall be appointed, removed and compensated as provided by Charter Article 9-1 and applicable code sections. For purposes of this section "Uniformed Service of the United States" shall mean either the United States Army, the United States Marine Corps, the United States Navy, the United States Air Force, Space Force, the United States Coast Guard, the United States Public Health Service Commissioned Corps, or the National Oceanic and Atmospheric Administration Commissioned Officer Corps. #### Sec. 2-854. Subcommittees.

Subcommittees may be appointed by the veterans' affairs commission to accomplish the objects and purposes of the veterans' affairs commission, and members appointed to such subcommittees need not be residents of the City or registered electors. (Code 1979, § 8-413)

# Sec. 2-855. Object and purpose.

The object and purpose of the veterans' affairs commission shall be to exercise those powers and duties as follows:

- (1) Shall advise the council as to the concerns of veterans relating to transportation, housing, employment and other areas affecting veterans in the City.
- (2) Shall make recommendations to the council of solutions to these issues and concerns.
- (3) May serve as a source of information regarding sources and services available to veterans.
- (4) Shall exercise such other powers and duties as may be assigned to it by the city council. (Code 1979, § 8-414)
