MINUTES

CALL TO ORDER: By Lori Sanchez at 1:00 PM

<u>ACFOA MEMBERS PRESENT</u>: Juanita Audre, Frances Dollard and, Derrick Vaughns, Karen Jorgensen, Caroline Kim, George Bain (*virtually*), Commissioners.

ACFOA MEMBERS ABSENT: Jeannie Davis, Chair; Barbara Schneller, Commissioner.

OTHERS PRESENT: Lori Sanchez, Interim Facility Program Supervisor ACAA, ACFOA Liaison; Officer James Seneca; Adriana Valles Morales, Admin Specialist and Secretary for ACFOA.

ADOPTION OF MINUTES: Upon motion, second, and unanimous vote, the June 5th meeting minutes were approved.

SPEAKER: Stephen Fauver, Senior Deputy District Attorney, Economic Crime Unit, has been with the 18th Judicial Office for 19 years. Stephen explained what they do and what types of crime cases are taken. For crimes against at-risk individuals, the victim must be 70 years or older or someone with disability (on wheelchair, intellectual disability, blind, missing limb, etc.) to fall under the Mandatory Reporting Law. Stephen spoke about the difference between at-risk statute and the mandatory reporting statute. For the suspect to be charged with an at-risk crime, they must commit the crime knowing the victim is considered at-risk. Crimes done by mail, internet, and phone are hard to process as an at-risk case due to not enough proof. "Undue influence" is a new term that was added under the at-risk financial exploitation statute: the use of influence to take advantage of an at-risk person's vulnerable state of mind, neediness, pain, or emotional distress. There are cases where the DA's office will prosecute a case even if the victim does not want to place any charges. Tips were given to help avoid identity theft: locking your credit card online, checking bank statements and reporting an issue

right away since it needs to be reported within 30 days of the date of transaction. Other recognizable crimes are stranger schemes like home repair contractors, travel schemes, computer pop-ups such as software expiration, virus alerts, etc. For call schemes you can hang up and not worry about being rude. If you do answer, try and use alternatives to the word, "yes." An important element to keep in mind if you run into a possible scheme, is perspective. Ask family or friends about their thoughts before you commit to anything. There are romance and extortion scams, family/acquaintance schemes: misuse of Power of Attorney, addition of co-owner rather than co-signer of a bank account, theft of valuable items, physical access to credit and debit cards, checks. If you know someone that needs help, don't be a detective yourself, let your friend know everything they can do, help organize documents and encourage them to contact an attorney when needed. To check the status of your case, call the District Attorney's office and they will let you know. James (Jamie) Sorrells, Director of Consumer Fraud Protection can be reached at consumer@coda18.gov. If law enforcement says a situation is a civil matter, contact Brian and their team will look at the case to make sure. Transportation Solutions – Lori Sanchez, Liaison

- Meeting was on June 20th and the speaker was Barbara Boyer with Age Wise Colorado. They
 have 300 different alternative transportation options on their website.
- RTD announced Zero Fare for Better Air Campaign. The public can ride the entire system for free for the months of July and August.

Intergenerational Support – Juanita Audre, Commissioner



The Committee has agreed to having an intergenerational program at the Aurora Center for
Active Adults. Lori and Steve spoke to a preschool and are working on having a reading program
where volunteers would be taken to the preschool to read to the children.

Fraud and Abuse Prevention Committee - George Bain, Commissioner

 The Committee will continue with the door knockers. There will be more information at the next meeting.

Housing Committee Discussion – Derrick Vaughns, Commissioner

- The goal of the committee is to educate aging adults on specific topics such as expanding the
 supply of aging-friendly housing options. Empty nesting is a term that can be found in the
 Colorado Housing Authority. Currently, Aurora is not designated (to Derrick's knowledge) as one
 of the cities utilizing this program. More research is being conducted and Derrick will get back
 with the Commissioners. The Golden Girl Theory is where a group of older adults move in
 together to co-house.
- Other topics to educate aging adults on are rental assistance, home repairs and modifications, and improving the links between housing and healthcare. There are many aging adults that have housing but don't have enough money for a nurse to come visit them at home. The Committee's goal is to research and find out how to link housing and healthcare together.
- How to act upon addressing older adult homelessness and how to educate the aging adult
 population facing this problem, such as a pamphlet with resources that can be handed out. The
 pamphlet could include information about affordability, physical accessibility, access to medical
 and other services, older adults in rural areas.
- Derrick would like to identify how many older adult homeless live in Aurora and are struggling.

OLD BUSINESS:
