## Letter of Introduction

This guide provides general information on Aurora's nomination petition process. Reliance solely on this document is not advised. Ultimately, candidates and petition circulators are responsible for compliance with the City Code.

The City Clerk and the City Attorney's Office do not represent the interest of candidates individually, but of the City generally, and are unable to offer legal advice to individual candidates or campaigns. Candidates are strongly encouraged to consult private legal counsel if they have questions on complying with the City of Aurora Election Code.

## NOMINATION PETITION STEPS

#### 1. **Pickup Nomination Petition Sections**

When: August 9, 2023 – August 29, 2023

Time: 9 AM – 4 PM **without** appointment

#### 2. **Circulate Nomination Petition Sections**

Petition sections are circulated by the candidate or petition circulators. The person circulating the petition is responsible for the document at all times and <u>must witness all signatures</u>. Petitions may not be left at a location.

#### 3. File Nomination Petition Sections

The nomination petition sections must be physically filed with the City Clerk's Office. Electronic filings are not accepted.

#### 4. Petition Validation

Within three (3) days after the petition is filed, the City Clerk's Office will verify that the required number of valid signatures are obtained.

If the City Clerk's Office determines there is an insufficient number of valid signatures, the candidate will have an opportunity to circulate additional petition sections to meet the signature requirement by the September 5<sup>th</sup> deadline to file amended nomination petitions.

### **GENERAL OVERVIEW**

Candidates for municipal office are nominated without regard to political party affiliation on petition sections supplied by the City Clerk's Office. The candidate's name, address, and municipal office they are seeking are required to be on the petition section prior to circulating.

Nomination petition sections may be picked up from the City Clerk's Office beginning August 9<sup>th</sup> at 8 a.m. and may be circulated for signatures through August 29<sup>th</sup>. Nomination petition sections must be filed with the City Clerk's Office by 5 p.m. on August 29<sup>th</sup>.

Do not remove the staples or otherwise disassemble the petition sections.

Altered petition sections will not be accepted.

#### SIGNATURE REQUIREMENTS

Registered electors signing the nomination petition must include their printed name, signature, complete address, city, county of residence, and the date the petition was signed. Blue or black ink is encouraged for legibility purposes.

Candidates for elective office are required to obtain at least the minimum number of registered electors' signatures, as noted below:

#### Mayor and At-Large

- A minimum of one hundred (100) valid signatures of registered electors residing *anywhere* within the city of Aurora.
- Registered electors may sign only one (1) candidate petition for the office of mayor and may sign up to two (2) candidate petitions for at-large offices.

#### Wards

- A minimum of fifty (50) valid signatures of registered electors residing within the same ward as the candidate from such ward.
- Registered electors may only sign one (1) candidate petition.

#### **Nomination Petition Circulators**

Circulators must be residents of Colorado, citizens of the United States, and at least eighteen years of age. The circulator is responsible for the nomination petition at all times and <u>must witness all signatures</u>. Each signer must be given the opportunity to read and understand the measure they are signing.

#### **Circulator Affidavit**

The Affidavit of Circulator is included in the back of each petition section and must be properly executed and returned with the petition. No additional signatures may be added to a petition section after the *Affidavit of Circulator* has been notarized.

#### Candidate

Candidates must be 21 years of age or older and have resided within the municipal boundaries of Aurora for at least one year immediately preceding the date of the election. Candidates for ward seats are required to be one-year residents of the respective wards from which they are elected.

#### **Acceptance of Nomination**

The written affidavit of the candidate accepting the nomination is included on the back of each petition section and must be properly executed and returned with the petition. The acceptance of nomination contains the place of residence of the candidate and the name of the candidate in the form that they wish for it to appear on the ballot. The candidate's name may be a nickname or include a nickname but shall not contain any title or degree designating the business or profession of the candidate.

#### Withdrawal of Nomination

Any person who has been nominated as a candidate for municipal election, and who has accepted a nomination, may submit a Withdrawal of Nomination Affidavit with the City Clerk at any time. A candidate's name will not appear on the ballot if they withdraw 60 days before the election. If the withdrawal occurs later than 60 days before the election, the candidate's name will remain on the ballot, however, any votes for that candidate will not be counted.

## **DEFINITIONS**

**Candidate** - Any person who seeks nomination or election to any public office of the city of Aurora that is to be voted on at a municipal election. A person is a candidate if:

- a) They have publicly announced their intention to seek election to public office.
   "Publicly announced" means organizing a candidate committee under ACC Sec.
   54-103 or announcing an intention to seek public office through a speech,
   statement, or other public communication.
- b) They have circulated, or authorized another person to circulate, nomination petitions on behalf of their candidacy for public office; or
- a) They have received a contribution or made an expenditure or authorized another person to receive a contribution or make an expenditure, to support the person's election to public office.

**Circulator** – A person who individually circulates a petition in an attempt to obtain signatures from qualified registered electors.

**Petition section** – The stapled or otherwise bound package of documents containing the warning, proposed summary or statement, signature pages, and affidavit of the circulator.

**Registered elector** - A resident of the city who is qualified to vote under the constitution and the statutes of the state and who is registered to vote.

**Regular municipal election** - An election held on the first Tuesday in November in odd-numbered years.
