Other Notes & Requirements:

*All dancers cast in this piece must be available for Dress Rehearsals on June 5 & 6 (once our official Recital dates have been finalized) in the evening & Recitals on June 7 & 8 in the afternoon & evening. This piece will be the Opening for the Pre Recital in the afternoon on June 8 & both Beg-Adv Recitals on June 7 & 8 (again, once our official Recital dates have been finalized).

*Dancers are only allowed TWO EXCUSED ABSENCES from Saturday rehearsals. We have already allotted for no rehearsal on Feb. 24 (Ms. Maggie conflict), March 2 (ADA/Davis Dance Show at The Aurora Fox), March 23 (Spring Break), May 18 (Ms. Maggie prior commitment) & May 25 (Memorial Day Weekend). Any rehearsal absence must be pre-approved by Ms. Maggie, except for an extenuating illness, which should also be communicated. Fewer absences are preferable for the process. Absences result in delays in the choreographic process. If you cannot commit to the rehearsal schedule, please do not accept your casting!
